## Descriptions of Available Reports

Name of Report	Description
Arbitrator Scorecard	Provides summary-level arbitrator statistics, including number of cases heard, decision cycle time, and returned decisions.
Award pay Requests	Report lists award pay notices sent or received during the timeframe selected.
Collaborative Hearing	Provides counts of personal rep and panel-of-three filings submitted and heard at a summary level with the ability to drill down to detail level.
Company Visible Report – TRS®	Lists companies a member can view and file on behalf of and companies/TPAs that can view and file on behalf of member.
Counter Claim Features by State	Provides the number of counter claim features filed.
Daily Arbitrator Productivity	Provides detailed information on features assigned and heard by arbitrators on a daily basis.
Damage Disputes Heard vs. Responded	Provides heard-to-filed ratio by company and state for damage disputes. Lists how many features had damages disputed and how many features with disputed damages were heard by company and state.
Deferments Requested	Lists deferments requested during selected timeframe and includes status of the deferment.
Feature Detail (Recovering or Responding)	Provides details for features filed by or against the company during a given timeframe, including damages sought, feature status, and claim rep. information.
Features Heard vs. Filed	Provides heard-to-filed ratio by company and state. Lists how many features were filed and heard by company and state.
Features Published Detail (Recovering or Responding)	Provides details for features filed by or against the company and heard during a given timeframe, including damages sought, award amount, and claim rep. information.
Features Ready to Hear	Provides a list of features in ready-to-hear status.

Features Withdrawn (Recovering or Responding)	Lists features withdrawn during given timeframe, including damages sought and claim rep. information.
Jurisdictional Exclusions	Lists Jurisdictional Exclusions raised by responding party and against recovering party.
No Response – Features Pending	Lists features filed against the company that have an outstanding response as of the date the report is run.
No Response – Features Published	Lists features filed against the company that have a published decision and no response was submitted.
Representative Productivity	Lists user activities completed during given timeframe in both summary and detail-level view.
Responding Party Features Answered	Lists features that were responded to during the specified timeframe with detail-level data.
Response Extensions Requested Detail	Lists features where an extension was requested by the responding company, including date requested and claim rep. information.
Revisits Activated	Lists revisits activated based on the responding party's response along with status of the revisit.
Revisits Pending	Lists features filed by the company that have an outstanding revisit as of the date the report is run.
